10. Any outdoor engagement is to have an alternate bad weather sight. Bad weather is defined as: weather conditions determined by **Byron Brewer** that prevents the band from performing in a professional and / or safe manner.
11. **Byron Brewer** and personnel employed by Byron Brewer shall be provided at no cost non-alcoholic beverages.
12. Non-alcoholic beverages are defined as soda, coffee, juices and bottled water served by purchaser at said engagement.
13. **Byron Brewer** shall at all times have complete supervision, direction and control over the services of his personnel on this engagement and expressly reserves the right to control the manner, means and details of the performance, as well as the means to be accomplished.
14. The agreement of **Byron Brewer** to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control.
15. Unless this contract and deposits are returned to this office within 21 days from agreement date, **Byron Brewer** reserves the right to declare this contract null and void.
16. It is understood that **Byron Brewer** executes this agreement as an independent contractor and is not an employee of the Purchaser.
17. In the act of Mother Nature and The Band is unable to perform, Byron Brewer is to be paid the full agreed price of this contract. Artist (Byron Brewer) to be paid rain or shine.
